# Disabilities Association of Ontario (LDAO) - Martin Smit

Mr. Smit provided an overview of the LD@school, a project funded by the Ministry of Education. <u>LD@school</u> is a bilingual web resource that provides educators with free supports for students with learning disabilities. LD@school features over 200 evidence-based and practice informed resources ready for classroom use. These resources include videos, webinars, podcasts and articles.

# 2.5. Staff Reports

2.5.1. Student Services Report - Francesca Mosier, Diane Lood, Paula Sorhaitz

### Francesca Mosier presented the Coordinator's Report.

- OrbitNote and Read and Write Training were provided on October 29<sup>th</sup> to the new Program Support Teachers
- DCART members attended the Geneva Centre for Autism Symposium on October 30th, 31st and November 1st. The 6 DCART team members learned about new practices in Applied Behaviour Analysis, communication strategies, and social skills for students on the spectrum.

### Diane Lood presented the Mental Health (MH) Report:

**Emotional Validation Workshop** 

- SMHO has introduced a training for support staff in using an emotional validation approach in working with students that may be experiencing intense emotions.
- **Emotional validation** is the process of *listening nonjudgmentally to a student and believing their emotional experience* rather than trying to change it.
- This workshop was presented to the chaplains on October 11<sup>th</sup>.
- Psychology staff were trained in providing Culturally Responsive Assessments using the Kaufman Assessment Battery for Children (KABC2NU).
- In our commitment to providing culturally responsive services to students, families, and schools, the Psychological Services team participated in a full day webinar on specific assessment instruments that suit that purpose. The training provided useful information and recommendations for the team.



- November 28th is DCDSB's Let's Talk Day with a focus on help-seeking
- Distribution of help-seeking materials, posters, announcements, lesson plans and a social media blitz.
- Applied Suicide Intervention Skills Training (ASIST) ran October 9th and 10th
- Violent Threat Risk Assessment (VTRA) Level 1 ran October 23rd and 24th

### Paula Sorhaitz presented the Superintendent's Report:

The Superintendent provided a breakdown of the most recent Program Support Teacher Meeting held on October 22nd and highlighted the following:

# Occupational Therapist Tiered Intervention Service Model

- an innovative, evidence-informed model to help OTs provide the right help, at the right time, in the right way, to any student.
- a 3-tiered model with different levels of support/intervention to provide regular and consistent services that support individual students, classrooms, and the entire school community.
- dynamic and fluid: Students can move between tiers.
- well-aligned with the Universal Design for Learning framework.

# OT Tier 1 Services are Universal Supports which:

- include classroom-wide strategies for grades JK- Grade 1 and some other classrooms where appropriate.
- are provided in classrooms in collaboration with teachers.
- are "good for all and necessary for some."
- support teachers' comfort and capacity to address students' goals related to motor skills, self-care skills, self-regulation skills, and sensory needs.
- may include recommendations for "tier one equipment."
- covered by the universal consent letter sent out by the school
